General terms and conditions

The workshop contents correspond to the online program and the program folder. Any changes or additions to the program will be communicated to the attendees at the beginning of the conference at the latest. Organizer of the workshop is Imago Gesellschaft Österreich, hereinafter referred to as organizer. Facilitator of the workshop is Maya Kollman, hereinafter referred to as workshop facilitator. Workshop materials are protected by copyright and may not be copied or used commercially without the consent of the organizer and the workshop facilitator. The organizer is entitled to change the schedule of the workshop as well as its venue and date in case of important reasons as long as the interests of the attendees aren't significantly compromised. By registering, attendees acknowledge that during the workshop video and sound recordings as well as pictures may be taken by the organizer's staff for marketing purposes. The organizer is allowed to publish these recordings/pictures in print media, in the Internet or in Social Media.

Registration

Terms of payment

The workshop fee has a fixed price. The payment deadline is 14 days from receiving the invoice (sent via email after registration). If the workshop fee isn't paid fully 14 days prior to the workshop, the registered participant is not entitled to attend the workshop and also receives no confirmation of attendance. The request of payment remains intact nevertheless.

Cancellation

In case of a written cancellation 8 weeks prior to the conference, the workshop fee will be refunded and a cancellation fee of \le 20,00 will be detained. In case of a cancellation less than 8 weeks prior to the conference, the cancellation fee is 100% of the workshop fee unless a substitute participant is provided by the participant. In this case, the attendance can be cancelled until the beginning of the conference and the workshop fee will be refunded (minus a cancellation fee of \le 20,00).

Right of withdrawal

Participants who register for the workshop as private individuals have the right to cancel their registration according to the Austrian consumer protection law within 14 days after registration. This is not valid if the registration is placed less than 14 days prior to the workshop. The withdrawal needs to be declared written (via email, letter, fax,...) without giving reasons within 14 days after registration.
